SHAPE DECISION-MAKING AGENDAS

In **Zambia**, PATH and partners mobilized champions to raise political visibility for newborn health, leading to adoption of the first-ever national policies for newborn care.

At the **global level**, our advocacy helped ensure targets for innovation in the Sustainable Development Goals, and in the **United States**, we helped to ensure additional resources for global health research and development.

In **Senegal**, PATH advocacy secured commitments to improve immunization supply chains as a fundamental way to reach every child with lifesaving vaccines, including investments in vaccine delivery systems (cold chain equipment and storage) and more reliable information to prevent stockouts.

MOBILIZE RESOURCES FOR HEALTH INVESTMENTS

PATH helped to spark a resurgence of broad **US** support for global maternal and child survival, with a US\$35 million increase in US spending alongside protection of funds for immunization and other health initiatives—a double boost for mothers and children around the world.

In the **Democratic Republic of Congo**, PATH and stakeholders worked with the Congolese government to unlock \$1.9 million to cofinance the purchase of vaccines for families and advance immunization equity.

RALLY IN A HEALTH CRISIS

In **Uganda**, advocates from the PATH-led USAID Advocacy for Better Health project allied to respond to an expected stockout of anti-tuberculosis and HIV/AIDS drugs, which would have put an estimated 250,000 lives at risk. High-profile advocacy averted the crisis and resulted in increased investments and distribution of the drugs at a critical moment.

When a **global** treaty threatened to restrict access to thimerosal, a safe and effective preservative for vaccines, PATH and partners intervened. Without swift action, this treaty could have significantly limited access to immunization, putting millions of lives at risk.

PAVE THE WAY FOR LIFESAVING INNOVATIONS TO REACH THOSE IN NEED

In **Vietnam**, PATH supported development of a new decree signed by the prime minister in 2016 that aims to reform and strengthen the country's immunization system and facilitate introduction of new vaccines.

In **South Africa**, PATH's advocacy helped propel procurement of the female condom to put the power of protection against unintended pregnancies and sexually transmitted infections in women's hands.

In **Guatemala**, PATH worked with the government to create and issue new policy guidelines for screening and treating patients for cervical cancer, the most deadly cancer for women. The guidelines now incorporate global recommendations and new screening technologies to better detect disease and save lives.

IMPROVE POLICIES TO INCREASE ACCESS

In **Kenya**, PATH and partners successfully advocated for an update to the essential medicines list to add amoxicillin for child pneumonia treatment, chlorhexidine to prevent newborn infections, and misoprostol use closer to communities to make childbirth safer for mothers.

In **India**, PATH successfully pushed for development of evidence-based policies for an emergency transport system that today provides thousands of mothers and babies in the state of Uttar Pradesh with faster access to emergency care.

EMPOWER COMMUNITIES FOR ACCOUNTABLE CHANGE AND IMPACT

In **Uganda**, through its USAID Advocacy for Better Health project, PATH strengthened the capacity of citizens to hold their leaders accountable for improved and more accessible health services, including reopened surgery centers, new facilities for wider patient access, new service offerings, and postings of new health providers where people seek care.

In **Zambia**, PATH's data-driven advocacy efforts along with many partners led to a significant shift in government policy that now allows trained community-based health workers to administer injectable contraception to women, resulting in wider access.
