Terms and Conditions

Eligibility

- 1. The program is for enterprises (Indian or global) and for individual innovators.
- 2. Product and process innovations that address climate change's impact on health system that spans across solutions to decarbonize operations at health facilities, digital and Al/ML tools for risk mitigation and adaptation for health systems, enhancing community engagement and capacity building on climate induced health hazards from Low Middle-Income Countries are eligible to participate.
- 3. Participating or proposed ventures should be independent entities, meaning that they should not be a subsidiary of an existing corporation or have legal ties to a government body.
- 4. Existing non-profits can participate; however, they should propose a new venturing idea or a newplan to transform their existing solutions into a more sustainable solution.
- 5. Category specific eligibility

Technology Readiness Level (TRL) considered for this challenge

- a. TRL 9 Technology has been applied in its final form and is operational with requisite regulatory approvals
- b. TRL 8 Technology is proven, developed and validated in clinical/community settings

Submission and Participation

- 1. Submissions which are incomplete will be deemed void and disqualified from the competition.
- 2. Submissions should be the original work of the participant, and should demonstrate positive, sustainable and scalable social impact in India (though not exclusively in the region).
- 3. Participants agree to the use of their names, photographs, disclosure of their country of residence, and are required to cooperate with any other reasonable requests by the organizer relating to any publicity-related activities
- 4. Participants are required to submit a declaration of good standing and solvency at the final stage of evaluation. If there is any change in circumstance that invalidates their good standing and solvency, the team is to immediately inform the organizers.
- 5. All participants own the rights to their ideas. Participants must properly acknowledge any trademarks, patented or copyrighted materials of others that are incorporated into the submission materials. Participants are responsible for obtaining any necessary permission before incorporating such materials into their submissions.
- 6. Submitted ideas are protected in the spirit of non-disclosure, and all submitted materials will be treated as company confidential. The only people with access to the entry materials will be judges and select members of the organizing committee. Materials will not be distributed to any other party unless requested by a participant. No other provisions are made to protect intellectual property.
- 7. As an effort to support the innovation ecosystem, for research purposes, non-sensitive data may be shared with government agencies or partner organizations. The participant's personal identity, name, family name, phone number, address, or email address will not be used in any public collateral.
- 8. Participants are advised not to disclose critical information which would affect a successful filing of patent(s). All presentations are open to the evaluator panel and organizer and some presentations may be videotaped. Any data or information discussed or divulged in public sessions by participants should be considered information that will likely enter the public realm, and entrants should not assume any right of confidentiality in any data or information discussed, divulged, or presented in these sessions.

Decisions Regarding the Winners

- 1. The selection of the 'Winners' is at the sole discretion of the judges. Best efforts will be made tomake decisions in accordance with this document.
- 2. Throughout any and all phases of Climate X Health Challenge, all decisions of the judges are final.

Disqualification and Organisers' Right to Amend Competition Rules

- 1. The organizers of Climate X Health challenge reserve the right to disqualify any Participant who is found to have violated the spirit of the program guidelines and terms and conditions stated herein.
- 2. The organizers reserve the right to amend these rules at any point before the Closing Date of the challenge in line with the overall goal of the program.
- 3. The indicated dates for the challenge may be revised at any point of time by the Organizers. Anychange in schedule will be suitably intimated on the challenge webpage and on other relevant platforms.

Privacy Policy

Your privacy is important to us. PATH is committed to respecting the dignity and privacy of people, balanced with the PATH values of transparency and accountability and the ability of PATH to carry outits mission. 2. How we use your personal information

3. How long we will keep your personal information

We will keep your personal information for the period required by law and where we need to do so in connection with legal action or an investigation involving PATH. Otherwise, we keep your personal information:

- where you have contacted us with a question or request, for as long as necessary to allow us to respond to your question or request.
- 4. We may share your personal information with others and transfer it internationally. We may share your personal information with the following trusted third parties:
 - our agents and suppliers, including those who provide us with technology services such as data analytics, hosting, email and direct mail services, and technical support;
 - our professional advisors, auditors, and business partners; and
 - regulators, governments, and law enforcement authorities.

5. How we protect your personal information

We use a variety of security measures and technologies to help protect your personal information from unauthorized access, use, disclosure, alteration, or destruction, in line with applicable data protection and privacy laws.
